2. DECLARATIONS OF MEMBERS INTERESTS: There were no declarations of interest.

3. MINUTES OF LAST MEETING: It was proposed by Cllr Markley and seconded by Cllr Allum that the minutes of the meeting held on 1st November 2006 be accepted as a true record.

4. MATTERS ARISING:

Parish Boundary Review: We have been advised by Haversham Parish Council, that they have formally advised Milton Keynes Council that they wish to have the Rocla site removed from their Parish.

Canal Villa, Marsh Drive: An appeal on this application has been made; the Parish Council has submitted its objections to the application.

Wharf House: An appeal has been made regarding the refusal of the application for new gates. The Parish Council will respond.

5. PLANNING APPLICATIONS:

06/01797 2 Tadmarton, Downhead Park: Concern about new front door and that the new first floor is completely separate from the current property. To advise Planning of this and to request a condition regarding family use only.

06/01800 Retirement Village, Willen Park: Concern about the sharp turn at the bottom of the slip road, will fire engines be able to negotiate this.

06/01854 6 Tanners Drive, Blakelands: No objections

06/01861 11 Woodruff Avenue, Conniburrow

06/01862 43 Yarrow Place, Conniburrow

06/01864 21 Marjoram Place, Conniburrow

06/01908 297 Conniburrow Boulevard, Conniburrow

The above four applications are identical, all have been converted to six bedsits. To object and ask that if granted the number of rooms be reduced to four, parking space be reversed, adequate bin storage be provided and appropriate fire precautions be installed.

06/01788 St Monicas School, Neath Hill: There are no objections to the plans, but due to the ongoing traffic problem around the school, to request that the work be carried out during the school holidays.

06/01871 86 Cattle Avenue, Downs Barn: The original application was refused due to the lack of information regarding parking. This application again does not make it clear where the parking is to be.

06/01890 Land adjacent to 220 Wolverton Road, Blakelands:

There will be an objection to this application as this is an inappropriate development and the design of the building does nothing to enhance the area.
